1. Roll Call

2. Public Comment:

Dan Falat. Introduced himself as State Park Section Superintendent and stated that, as a representative from California State Parks, he wanted to highlight his agencies' desire to be involved in the planning process for the Gaviota coast and that he would be attending the GavPAC meetings on a regular basis.

3. Meeting Minutes from November 4, 2009

Public Comment: None

Deliberation: McNabb suggested adding Ed Yates to the staff list, and the open meetings law presentation as a line item.

ACTION: Baer moved, seconded by Lloyd, and carried by a vote of 11-0 to approve the minutes as revised.

4. Election of Vice-Chair and Recording Secretary

Public Comment: None

Deliberation: Chair Kimbell opened the election asking GavPAC members for nominations or volunteers to serve as Vice-Chair. Lloyd volunteered.

ACTION: Appointed Mark Lloyd as Vice-Chair and Vicki Parker, Long Range Planning Deputy Director, as recording secretary.

5. Long-Term GavPAC Meeting Schedule

Public Comment:

Bill Giorgi. Stated preference for early GavPAC review of the plan area boundary. Expressed concerns regarding information from the Coastal Commission regarding limits on the recognition of legal lots via the Certificate of Compliance (CC) process. Asked how the Agricultural Advisory Committee (AAC) will be informed about GavPAC discussions that may affect agriculture, and how comments by the



AAC will be incorporated into GavPAC deliberations. Staff responded by reiterating the long-standing County practice of acknowledging legal lots through the CC process consistent with the Subdivision Map Act and that Staff will go before the AAC at appropriate intervals to report about the Gaviota Coast Plan process, and report back to the GavPAC with AAC comments.

Deliberation: GavPAC discussed ways to compress the educational/informational phase in favor of an extended issues deliberation phase. The GavPAC also discussed utilizing third-party issue area experts during the educational/informational phase. The GavPAC requested that staff work with the Chair and Vice-Chair and return with options to modify the meeting schedule.

ACTION: Tautrim moved, seconded by McGinnis, and carried by a vote of 6-5 to move the December 9, 2009 meeting to December 7, 2009.
