***Adoption of the  
Los Alamos Community Plan Update and  
Final Environmental Impact Report***

On Tuesday February 15, 2011, the Santa Barbara County Board of Supervisors will conduct a public hearing in the Betteravia Government Center Board Hearing Room located at 511 East Lakeside Parkway in Santa Maria beginning at 9:00 a.m. The hearing is to consider a recommendation from the Planning Commission regarding the adoption of the Los Alamos Community Plan (LACP), pursuant to Government Code §§65355, 65856, and 65090 and Final Environmental Impact Report (EIR)(08EIR-00000-00005). The County of Santa Barbara is the lead agency preparing the Final EIR to inform decision-makers and the public regarding potential environmental impacts related to the draft LACP in compliance with the California Environmental Quality Act (CEQA), (Public Resources Code §21000 et seq.).

Adoption of the LACP includes amendments to the Santa Barbara County Comprehensive General Plan and Land Use and Development Code. The public hearing culminates a multi-year effort by the Los Alamos community and the County to develop a plan to guide physical development in the Los Alamos area. The Final LACP EIR was released on July 23, 2010 and includes all public comments received on the Draft EIR (released for public review on September 25, 2009 and the County's responses (CEQA Guidelines §15132).

Pursuant to Government Code Section 65090 (d), notice is being provided to persons in the community, including the blind, aged, and disabled persons who could be affected by the propose removal of "Drive Through Facility" uses from uses permitted in the existing C-2 zoning in downtown Los Alamos with the proposed rezone to the new Community Mixed Use Los Alamos (CM-LA) zone district.
