7. **LAPAC to Consider Communication with Verizon** – At the January 28 meeting, Chris Wrather brought to the attention of the LAPAC limitations on Verizon's high-speed internet service to Los Alamos. The LAPAC will consider authoring a letter to Verizon requesting expansion of internet service capabilities. Cable services may also be discussed.
