## ***NOTICE OF PUBLIC HEARING*** ***Adoption of the Los Alamos Community Plan Update***

On Wednesday, August 11, 2010, the Santa Barbara County Planning Commission continued until Wednesday, October 13, 2010 its hearing to consider a recommendation to the Board of Supervisors regarding the adoption of the Los Alamos Community Plan (LACP) update, pursuant to Government Code §65353, and proposed Final Environmental Impact Report (EIR)(08EIR-00000-00005). The County of Santa Barbara is the lead agency preparing the proposed Final EIR to inform decision-makers and the public regarding potential environmental impacts related to the LACP update in compliance with the California Environmental Quality Act (CEQA), (Public Resources Code §21000 et seq.).

Adoption of the LACP update includes amendments to the Santa Barbara County Comprehensive General Plan and Land Use and Development Code. The public hearings culminate a multi-year effort by the Los Alamos community and the County to develop a plan to guide physical development in the Los Alamos area.

The proposed Final LACP Update EIR was released on July 23, 2010 and includes all public comments received on the Draft EIR (released for public review on September 25, 2009) and the County's responses (CEQA Guidelines §15132).
