SUBJECT: PROPOSED ORDINANCE AMENDMENT TO CHAPTER 35B OF THE
SANTA BARBARA COUNTY CODE TO AMEND AND EXTEND THE LIFE
OF THE MONTECITO GROWTH MANAGEMENT ORDINANCE (MGMO).

NOTICE IS HEREBY GIVEN that on Tuesday, October 5, 2010, the County Board of Supervisors will conduct a public hearing to consider the recommendation of the Montecito Planning Commission on the following:

- a) **09ORD-00000-00014:** An ordinance renewing and amending Chapter 35B of the County Code, Montecito Growth Management Ordinance; extending the life of the ordinance to December 31, 2030; and
- b) **10EIR-00000-00003:** Certification of the proposed Final Supplemental Environmental Impact Report along with the Revision Letter dated September 1, 2010, revising 92-EIR-03, as complete and adequate environmental review for 09ORD-00000-00014 in compliance with CEQA.

The County of Santa Barbara is the lead agency preparing the proposed Final SEIR, supplementing the Montecito Community Plan EIR (92-EIR-03), to inform decision-makers and the public regarding potential environmental impacts related to the MGMO Renewal, Amendments, and Extension in compliance with the California Environmental Quality Act (CEQA), (Public Resources Code §21000 et seq.).

The proposal is to renew, amend, and extend the MGMO as an implementation measure of the Montecito Community Plan. The proposed project would affect all Coastal Zone and inland properties within the Montecito Community Plan Area.
