RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA

IN THE MATTER OF RESUBMITTING TO THE )  
REGIONAL COMMISSION THE REVISED VERSION )  
OF THE PREVIOUSLY DISAPPROVED PORTIONS )  
OF AN ADOPTED LAND USE PLAN FOR THE UN- ) RESOLUTION NO. 80 - 392  
INCORPORATED COASTAL ZONE OF SANTA )  
BARBARA COUNTY PURSUANT TO THE CALIFORNIA )  
COASTAL ACT OF 1976 )

WITH REFERENCE TO THE FOLLOWING:

A. The County of Santa Barbara adopted a land use plan including text and maps for its coastal zone in accordance with the California Coastal Act of 1976 (Pub. Res. C. § 30000 and following).

B. Portions of this land use plan have been approved by the California South Central Coast Regional Commission and forwarded to the State Coastal Commission. Other portions of this land use plan were disapproved by the Regional Commission and were returned to the County for revision.

C. After duly noticed public hearings before this Board, the disapproved portions of the land use plan, together with the Regional Commission's written explanation and suggestions, were reconsidered and the disapproved portions were revised and adopted by this Board on August 4 and 11, 1980. This adopted revised version is attached hereto as Exhibit "A" (consisting of 13 pages) and incorporated herein by this reference.

D. This revised version of the land use plan is consistent with and intended to implement at the local level the provisions of the Coastal Act of 1976.

E. This Board now wishes to resubmit this revised version to the Regional Commission.

NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

1. The above recitations are true and correct.
2. This Board certifies that the attached revised version (Exhibit "A") is intended to be carried out in a manner fully in conformity with the said California Coastal Act.

3. This Board resubmits the attached revised version (Exhibit "A") of the land use plan to the South Central Coast Regional Commission for review and approval.
