13 WITH REFERENCE TO THE FOLLOWING:

14 A. On March 2, 1981, the County of Santa Barbara, by its
15 Resolution No. 81-90, resubmitted a revised Land Use Plan for
16 its coastal zone to the California Coastal Commission for
17 review and certification.

18 B. On March 17, 1981, the State Coastal Commission
19 certified the plan as resubmitted with the exception of the
20 following issues, which were refused certification: (1) the
21 east urban/rural boundary in Summerland and the land use
22 designations between Greenwell Avenue and the more easterly
23 County proposed urban/rural boundary, (2) the west urban/rural
24 boundary in Goleta and the land use designations for the
25 Haskell's Beach property, and (3) policy 8-9 and all of the
26 special policies pertaining to the Channel Islands contained
27 in Section 4.8 of the Land Use Plan text.

28 C. After two public hearings, this Board now wishes to
29 revise the first two uncertified issues, as described in
30 Paragraph B., above, and resubmit these two revised issues to
31 the California Coastal Commission for review and certification.

32 D. These two revisions are intended to implement at the
local level the provisions of the California Coastal Act of
1976 (PRC § 30000 and following).

1 NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

2 1. The above recitations are true and correct.

3 2. This Board adopts pursuant to Government Code § 65303 (k)
4 the local coastal element, the revisions to the certified Land
5 Use Plan of the Local Coastal Program contained in ADDENDUM # 2,
6 dated April 27, 1981, and consisting of 23 pages, and certifies
7 that it is the intention of this Board to carry out the
8 provisions of this Land Use Plan.

9 3. This Board hereby directs the Clerk of this Board to
10 resubmit these revisions to the certified Land Use Plan directly
11 to the California Coastal Commission for review and certification,
12 pursuant to PRC § 30512 (d).
