

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA

IN THE MATTER OF APPROVING AND )  
AUTHORIZING RESUBMITTAL TO THE )  
CALIFORNIA COASTAL COMMISSION )  
OF A PROPOSED LAND USE PLAN FOR ) RESOLUTION NO. 81-90  
THE UNINCORPORATED COASTAL ZONE )  
OF SANTA BARBARA COUNTY PURSUANT )  
TO THE CALIFORNIA COASTAL ACT )  
OF 1976 )

WITH REFERENCE TO THE FOLLOWING:

A. In January 1980, the County of Santa Barbara, by its  
Resolution No. 80-12, submitted a Land Use Plan for its coastal  
zone to the California Coastal Commission for review and  
certification.

B. On December 2, 1980, after hearings at the South Central  
Coast Regional Commission and the Coastal Commission, the Coastal  
Commission refused certification of the County's Land Use Plan,  
as set out in the Commission's findings adopted January 22, 1981.

C. After public hearings in January, February, and March  
1981, this Board has revised the County's Land Use Plan and  
wishes to resubmit said revised Land Use Plan directly to the  
Coastal Commission for certification pursuant to PRC § 30512 (d).

D. The revised Land Use Plan for the coastal zone consists  
of the original text (311 pages), the original seven land use  
maps, the original sixteen resource maps, and the Addendum to the  
Coastal Plan (42 pages), dated March 2, 1981, which amends the  
originally submitted Land Use Plan.

E. This revised Land Use Plan is intended to implement at  
the local level the provisions of the California Coastal Act of  
1976 (PRC § 30000 and following).

1 NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

2 1. The above recitations are true and correct.

3 2. This Board adopts pursuant to Government Code § 65303(k)  
4 the local coastal element, the Land Use Plan of the Local Coastal  
5 Program consisting of a text (311pages), seven land use and sixteen  
6 resource maps, and the Addendum to the Coastal Plan (42 pages),  
7 and certifies that it is the intention of the Board to carry out  
8 the provisions of this Land Use Plan.

9 3. The Board hereby directs the Clerk of this Board to  
10 resubmit this revised Land Use Plan directly to the California  
11 Coastal Commission for review and certification, pursuant to  
12 PRC § 30512 (d).
