WITH REFERENCE TO THE FOLLOWING:

- A. On January 7, 1980, by Resolution No. 80-12, the Board of Supervisors of the County of Santa Barbara adopted the Santa Barbara County Coastal Plan.
- B. On July 19, 1982, by Ordinance 3312, the Board of Supervisors of the County of Santa Barbara adopted the Santa Barbara County Coastal Zoning Ordinance, Article II of Chapter 35 of the Santa Barbara County Code.
- C. Santa Barbara Shores Policy 1 of the Coastal Land Use Plan requires that a Specific Plan be prepared for the entire Ellwood Beach/Santa Barbara Shores site, in addition to the Planned Development requirements; Article II, the Coastal Zoning Ordinance, § 35-75.5, provides that, where the Coastal Land Use Plan requires a Specific Plan, the Specific Plan must be filed and approved prior to submittal of a Preliminary Development Plan.
- D. It is now deemed to be in the interest of orderly development of the County and important to the preservation of the health, safety, and general welfare of the residents of said County to amend the Local Coastal Program as follows:

89-SP-002: Adopt the Ellwood Beach/Santa Barbara Shores Specific Plan, dated June 1993, including the plan text and related maps, figures, tables and illustrations; development standards; and appendices.

- E. As required by Government Code § 65453, public officials and agencies, civic organizations, and citizens have been consulted on and have advised the Planning Commission on the proposed amendments in a duly noticed public hearing pursuant to Government Code § 65353, and the Planning Commission has sent its written recommendations to the Board pursuant to Government Code Section 65354.
- F. As required by Government Code § 65453, this Board has held a duly noticed public hearing, pursuant to Government Code § 65355 on the proposed amendments, at which hearing the amendments were explained and comments invited from the persons in attendance.
- G. These amendments to the Local Coastal Program are consistent with the provisions of the Coastal Act of 1976, and the Santa Barbara Coastal Land Use Plan, and the requirements of State Planning and Zoning laws as amended to this date, and are attached hereto as Exhibit 1 and incorporated as though fully set forth herein.
- H. The Board will submit these amendments to the California Coastal Commission for certification on the next appropriate date.

NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

- 1. The above recitations are true and correct.
- 2. Pursuant to the provisions of Government Code §§ 65453, 65356, and Public Resources Code § 30514, the above-described changes are hereby adopted as amendments to the Local Coastal Program of Santa Barbara County.
- 3. This Board certifies that these amendments are intended to be carried out in a manner fully in conformity with the California Coastal Act.
- 4. The Board will submit these Local Coastal Program amendments to the California Coastal Commission for review and certification on the appropriate date.
- 5. The Chairman and the Clerk of this Board are hereby authorized and directed to sign and certify all maps, documents and other materials in accordance with this Resolution to reflect the above-described action by the Board of Supervisors.


