WITH REFERENCE TO THE FOLLOWING:

A. On January 7, 1980, by Resolution No. 80-12, the Board of Supervisors of the County of Santa Barbara adopted the Santa Barbara County Coastal Plan and Zoning to be consistent with the Coastal Plan.

B. On July 19, 1982 by Ordinance 3312, the Board of Supervisors of the County of Santa Barbara adopted the Santa Barbara County Coastal Zoning Map identified as the Carpinteria Coastal Plan Land Use Map.

C. It is now deemed to be in the interest of the orderly development of the County and important to the preservation of the health, safety and general welfare of the residents of said County that the Board of Supervisors amend the Local Coastal Program by amending the Land Use designation for: Assessor Parcels Numbers 155-200-082, 155-200-084, 001-030-034 and 001-030-036 by changing the Land Use Designation from A-I-10 (10 acre minimum parcel size) to A-I-40 (40 acre minimum parcel size), the Zoning Designation from AG-I-10 to AG-I-40.

NOW, THEREFORE, IT HEREBY RESOLVED as follows:

1. The above recitations are true and correct.
2. Pursuant to the provisions of Section 65356 of the Government Code and Section 30514 of the Public Resources Code, the above described changes are hereby adopted as amendments to the Santa Barbara County Coastal Program.
3. This Board certifies that these amendments are intended to be carried out in a manner fully in conformity with the said California Coastal Act.
4. This Board submits these Local Coastal Plan amendments to the California Coastal Commission for review and certification.
5. The Chairman and the Clerk of this Board are hereby authorized and directed to sign and certify all maps, documents and other materials in accordance with this resolution to reflect the above

described action by the Board of Supervisors.
