WHEREAS, on December 22, 1980, by Resolution No. 80-566, the Board of Supervisors of the County of Santa Barbara adopted a Comprehensive Plan Land Use Element, and Environmental Resource Management Element, and on January 29, 1979, by Resolution No. 79-43A, the Board of Supervisors adopted a Seismic Safety and Safety Element, and on May 29, 1979, by Resolution No. 79-313, the Board of Supervisors adopted an Open Space Element; and on November 3, 1975, by Resolution No. 75-848, the Board of Supervisors adopted a Scenic Highways Element; and

WHEREAS, the Board of Supervisors has adopted Articles III and IV of Chapter 35 of the Santa Barbara County Code implementing the Comprehensive Plan.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

The Board of Supervisors hereby initiates the Agricultural Element Project Description, Exhibit A attached and incorporated by reference herein, and including:

1. The text of the proposed element which contains Goals and Policies for agriculture and one new land use designation, i.e. Commercial Agriculture (AC) (81-6P-3),
2. Policy and text amendments to the Land Use, Environmental Resource Management, Seismic Safety and Safety, and Scenic Highways Elements (81-GP-3) to provide internal consistency, and
3. Articles III/IV Zoning Ordinance Amendments to the County Zoning Ordinances, Chapter 35 Articles III and IV, to provide consistency of the Zoning Ordinance with the Comprehensive Plan for consistency.


