RESOLUTION NO. 90-855

WHEREAS safe and responsible management of hazardous wastes is critical to the protection of the public health, the environment, and the economic growth of our County; and

WHEREAS local land use planning, health and safety, and environmental protection should be the basis for determining the siting of any hazardous waste facility; and

WHEREAS the County has prepared a Hazardous Waste Management Plan consistent with Section 25135 of Chapter 6.5 of the Health and Safety Code and the guidelines for the Preparation of County Hazardous Waste Management Plans prepared by the State Department of Health Services; and

WHEREAS the Hazardous Waste Management Plan was prepared in cooperation with other County departments and an advisory committee representing the cities, environmental and industry interests, and the general public, and was approved by each of the city councils and this Board; and

WHEREAS Government Code Section 65303 authorizes the adoption of optional elements to the County Comprehensive Plan which, in the judgement of the legislative body, relate to the physical development of the County; and

WHEREAS the goals, policies, and implementation programs of the HWMP are designed to minimize the environmental, public health, and economic impacts of hazardous waste management in the County, and therefore the County should move forward with adoption of the Hazardous Waste Management Plan as the Hazardous Waste Element of the Comprehensive Plan; and

WHEREAS a program Environmental Impact Report (88-EIR-14) and addendum were prepared to assess the impacts of implementation of the goals, policies, and programs proposed in the Hazardous Waste Management Plan; and the EIR and addendum were certified pursuant to CEQA Section 15090; and a second addendum has been prepared to assess a subsequent amendment to the Plan; and

WHEREAS public officials and agencies, civic organizations and citizens have been consulted on and have advised the Planning Commission on the merits of the Hazardous Waste Management Plan; and

WHEREAS the Planning Commission has recommended by Resolution 90-28 the adoption of the Hazardous Waste Management Plan as the Hazardous Waste Element of the Comprehensive Plan; and

WHEREAS the findings required by CEQA Section 15091 regarding significant environmental impacts have been made; and

WHEREAS a Mitigation Monitoring and Reporting Plan has been prepared which meets the requirements of CEQA Section 21081.6 and will ensure that all mitigation measures identified in 88-EIR-14 will be monitored for the duration of the life of the Hazardous Waste Element of the Comprehensive Plan, and that periodic reports will be submitted to the Planning Commission and/or Board of Supervisors on the status of the mitigation measures.

NOW THEREFORE BE IT RESOLVED that the County of Santa Barbara adopts the Hazardous Waste Management Plan dated November 1988, as amended on February 20, 1990, as the Hazardous Waste Element of the County Comprehensive Plan.
