WITH REFERENCE TO THE FOLLOWING:

A. On March 5, 1979, by Resolution No. 79-134, the Board of Supervisors of the County of Santa Barbara adopted a "Noise Element" and related 5 Noise Element Contour Maps.

B. It is now deemed in the interest of the orderly development of the County and important to the preservation of the health, safety and general welfare of the residents of the County to adopt an amendment to the text of the Noise Element of the Comprehensive Plan as follows:

1. In the text, revise Policy No. 7 on page 60 to read:

"7. For protection of sensitive activities, as well as the airports, noise sensitive land uses, other than hotels and motels insulated to the level prescribed in the State Noise Insulation Standards, should not be permitted within the 65dB CNEL contour of any airport as projected in the County Airport Land Use Plan.

In no case shall institutional land uses, such as schools, hospitals, convalescent homes, and other in-patient health care facilities, be permitted within the boundaries of such 65dB CNEL Contour."

2. Renumber certain policies as follows:

- a. Renumber Policies 7 and 8 to 3 and 4 respectively;
- b. renumber Policies 3 through 6 to 5 through 8 respectively.

3. Amend the Airport Noise Contours on NOISE-3 (GOLETA), NOISE-5 (LOMPOC) and NOISE-6 (SANTA MARIA) to match those shown on the Airport Land Use Plan's Maps.

C. The Planning Commission of the County of Santa Barbara, after holding duly noticed public hearings on all of the above described items B-1 through B-3 has endorsed and transmitted to this Board said recommended changes on items B-1 through B-3 by its Resolution No. 85-16, pursuant to Government Code § 65354.

D. This Board has held a duly noticed public hearing on all of the above described items, as required by Government Code § 65355.

NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

- 1. The above recitations are true and correct.

2. Pursuant to the provisions of Government Code § 65356, the three above changes in the Noise Element of the the Comprehensive Plan of the County of Santa Barbara are adopted as an amendment to the above mentioned Comprehensive Plan Text and Maps. The motions for approval on the above described items were passed by the following votes:






