WITH REFERENCE TO THE FOLLOWING

- A. On May 29, 1979, by Resolution No. 79-313, the Board of Supervisors of the County of Santa Barbara adopted Comprehensive Plan Open Space Element for the County of Santa Barbara.
- B. It is now deemed in the interest of the orderly development of the County and important to the preservation of the health, safety, and general welfare of the residents of said County to adopt the following amendment to the Open Space Element of the Comprehensive Plan:
 - 1. Amend the description of "Geologic Problems Index V, on page 78 to read:

"These lands are subject to severe geologic problems including combinations of high ratings for any or all of the following: seismic severity (ground shaking), tsunamis or seiches, liquefaction, slope stability, expansive soils, soil creep, compressible/collapsible soils, and high groundwater. Moore & Taber, authors of the Seismic Safety Element, believe that the severity of geologic problems is great enough to warrant retention of these lands in their natural state, or they may be used for very light recreation, cultivated agriculture or grazing if

appropriate. (See Geologic Problems Index Maps, Seismic Safety Element)"

- C. Public officials and agencies, civic organizations, and citizens have been consulted on and have advised the Planning Commission on the said proposed amendments(s) in a public hearing pursuant to Section 65353 of the Government Code, and the Planning Commission has sent its written recommendations to the Board pursuant to Section 65354 of the Government Code.
- D. This Board has held a duly noticed public hearing, as required by Section 65355 of the Government Code, on the proposed amendment(s), at which hearing the amendment(s) was/were explained and comments invited from the persons in attendance.

NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

- 1. The above recitations are true and correct.
- 2. Pursuant to the provisions of Section 65356 of the Government Code, the above-described change in the Comprehensive Plan are adopted as an amendment to the above mentioned Plan Text.
- 3. Pursuant to the provision of Government Code Section 65357, the chair and the Clerk of this Board are hereby authorized and directed to sign and certify all documents and other materials in accordance with this Resolution to show the above-mentioned action by the Board.
 - 4. Pursuant to the provision of Government Code Section

65357, the Clerk of the Board is hereby authorized and directed to send endorsed copies of said Resolution to the planning agency of each city within this County.
