

# NOTICE OF PREPARATION

## of an Environmental Impact Report for the Winery Ordinance Update Project

The Planning & Development Department is the lead agency for preparation of a program Environmental Impact Report for the County of Santa Barbara Winery Ordinance Update project. A first step in the EIR process is for the lead agency to prepare and distribute a Notice of Preparation (NOP) to provide notice that an EIR is being prepared and to solicit comments from Responsible Agencies, Trustee Agencies, public agencies, organizations and other interested persons on the scope and content of the environmental information to be included in the EIR. A NOP was issued on Wednesday, June 25, 2014 for a 30-day comment period ending Thursday, July 24, 2014.

Planning and Development will conduct an Environmental Scoping Meeting on Wednesday, July 16, 2014 to provide an additional opportunity for the public to comment on the scope and content of the environmental issues to be addressed in the EIR.
